Next meeting July 15, 2024 at 7:30 p.m. at TTAB. Fiscal Officer reported Sara Hammer and Marge Shymanski to attend Northeast Planning and Zoning Workshop on June 28, 2024.

BOARD OF ZONING APPEALS: No report.

TRUMBULL TOWNSHIP FIRE AND RESCUE: Chief Berlinski reported mutual aid to Hartsgrove, diesel was ordered, requested fire department gas and diesel tanks be identified to help with delivery of material.

ROAD AND BRIDGE: Trustee Niewiadomski reported road maintenance is on-going; Hoffman road closing for crossover pipe replacement is complete. The Fiscal Officer presented driveway permit check from Mark Smith for 2851 Trask road, Trustees designated road supervisor Sypniewski to process.

OLD BUSINESS: Trustee Niewiadomski reported on Hoffman road will start ordering #304 limestone and will talk with Martuccio Asphalt & Paving, talked with Vince Gildone, he assured me required documents are completed when medical assistance is needed. Trustee Reed reported approved roof repairs for road department back building and cemetery vault.

The Chairman opened the floor for comments from others in attendance who desired to speak. Residents inquired about the fire department's condition of trucks and safety equipment current or out of date, maintain condition of equipment list, dry hydrant usage, grant application process, township park playground equipment condition, if Northwest Ambulance District is full time and current response time. The Board stated dry hydrant inspection up-to-date, hired grant writer to apply for new fire truck 3 – 4 years out, NAD is staffed full time, planning on improving park equipment.
